5.1 The Rail North Director introduced the report and pointed out that the 2016/17 budget was unchanged from the previously discussed amount, but that there would be a need to re-visit staffing and resource levels in future years given the level of ambition.



- 5.2 The report of the Rail North Director was considered and the following was agreed:
 - that WYCA set up bank accounts under the Authority's arrangement with Lloyds Bank
 - that the Rail North Director is delegated as signatory to the company bank accounts.
 - That the company address for Rail North Ltd is amended to Wellington House, 40-50 Wellington Street, Leeds, LS1 2DE
 - That external auditors are appointed at an estimated cost of c.£5k pa
 - That the appointment of auditors is delegated to the Rail North Director with assistance from WYCA using the mechanism in place for local authority appointment of auditors.
 - That Rail North Directors on the Partnership Strategic Board are agreed as David Hoggarth, Tobyn Hughes and Phil Barrett
- 5.3 The appointment of a Company Secretary was deferred to the next meeting of the Board.
